Finally my roommate got up and answered the intercom and the guy said he was FedEx. She asked him who the package was for and found that he did not have either of our names and asked him to leave. The guy continued to ring the intercom until he finally somehow got into the building. Once in the building the guy proceeded to do the same thing as he did downstairs except this time with our doorbell and pounding really hard on the door. My roommate finally called the police. After a day of speaking with police and detectives and them being thoroughly convinced that we were not CROOKS they let us in on the situation.
